

**Lake Linden-Hubbell Public Schools
Board of Education
Regular Meeting
February 8, 2021**

Due to the COVID-19 pandemic, the Regular Meeting of the Lake Linden-Hubbell Schools Board of Education was held virtually, using Google Meet, on Monday, February 8, 2021. The meeting was called to order by President Patricia Burton at 5:30 p.m.

Mr. Brad Codere gave a Superintendent/K-12 Principal Report. The repairs on the New Holland tractor have been completed. Unfortunately some other issues have been identified. Cost estimates are being explored. The second lockdown drill of the year was held on January 19 at lunchtime. The next one will take place on March 5. There will be an area-wide Teacher Inservice on Friday, February 19. The day will include a presentation by a mental health expert as well as staff receiving the second dose of the COVID vaccine. Parent Teacher Conferences will be held on February 24 and will be conducted the same way they were in the fall. With athletics finally able to resume, we have a full schedule of events.
