

**Lake Linden-Hubbell Public Schools**  
**Board of Education**  
**Reorganizational Meeting**  
**January 12, 2026**

The Reorganizational Meeting of the Lake Linden-Hubbell Schools Board of Education was held in Room 102 of the High School building on Monday, January 12, 2026. The meeting was called to order by Superintendent Emily Geiger at 5:30 p.m.

The meeting opened with the Pledge of Allegiance.

As the highest ranking officer, Patricia Burton was named temporary Chairperson and took over conducting the meeting.

A motion was made by David Anderson and supported by Jennifer Beaudette to accept the agenda. Roll call vote. Motion unanimously carried.

President Patricia Burton called for expressions from the public. Beth Krause addressed the Board.

A motion was made by David Anderson and supported by Lori Ambuehl that Patricia Burton be nominated as President of the Board of Education for 2026. There being no other nominations, the nominations were closed. Roll call vote. Ayes: Jeff Dennis, Jennifer Beaudette, Lori Ambuehl, Patricia Burton, David Anderson, Melissa Corrigan. Nays: Courtney Holzberger. Motion carried and Patricia Burton was declared elected President by majority vote.

A motion was made by Lori Ambuehl and supported by David Anderson that Jeff Dennis be nominated as Vice President of the Board of Education for 2026. A motion was made by Melissa Corrigan that Courtney Holzberger be nominated as Vice President of the Board of Education for 2026. There being no other nominations, the nominations were closed. Roll call vote for Jeff Dennis. Ayes: Jeff Dennis, Jennifer Beaudette, Lori Ambuehl, Patricia Burton,

David Anderson. Nays: Melissa Corrigan, Courtney Holzberger. Motion carried and Jeff Dennis was declared elected Vice President by majority vote.

A motion was made by Patricia Burton and supported by Jeff Dennis that Lori Ambuehl be nominated as Secretary of the Board of Education for 2026. There being no other nominations, the nominations were closed. Roll call vote. Ayes: Jeff Dennis, Jennifer Beaudette, Lori Ambuehl, Patricia Burton, David Anderson, Melissa Corrigan. Nays: Courtney Holzberger. Motion carried and Lori Ambuehl was declared elected Secretary by majority vote.

A motion was made by Lori Ambuehl and supported by David Anderson that Jennifer Beaudette be nominated as Treasurer of the Board of Education for 2026. There being no other nominations, the nominations were closed. Roll call vote. Ayes: Jeff Dennis, Jennifer Beaudette, Lori Ambuehl, Patricia Burton, David Anderson, Melissa Corrigan. Nays: Courtney Holzberger. Motion carried and Jennifer Beaudette was declared elected Treasurer by majority vote.

The following Board of Education members will serve as Trustees during 2026: David Anderson, Melissa Corrigan and Courtney Holzberger.

A motion was made by Lori Ambuehl and supported by Jennifer Beaudette that the School District Bylaws be adopted as written in the NEOLA manual; that the Board of Education shall conduct supervision of the District according to the laws of the State of Michigan; that the School District shall be operated as a General Powers School District. Roll call vote. Motion unanimously carried.

A motion was made by Jennifer Beaudette and supported by Jeff Dennis that Regular Board meetings shall be held on the second Monday of each month starting at 5:30 p.m. in Room 102 of the High School. Roll call vote. Motion unanimously carried.

A motion was made by Jennifer Beaudette and supported by Lori Ambuehl designating the Office of the Superintendent to be responsible for posting public notices for all Board of Education meetings. Roll call vote. Motion unanimously carried.

A motion was made by Jeff Dennis and supported by Jennifer Beaudette to accept the Board of Education Committee assignments for 2026. Roll call vote. Motion unanimously carried.

A motion was made by Lori Ambuehl and supported by David Anderson to appoint Jennifer Beaudette as the Lake Linden-Hubbell Board of Education Delegate to the Copper Country Association of School Boards, and David Anderson as Alternate Delegate, for 2026. Roll call vote. Motion unanimously carried.

There being no further business to discuss, a motion was made by Lori Ambuehl and supported by Jeff Dennis to adjourn the meeting at 5:50 p.m. Roll call vote. Motion unanimously carried.
