

**Lake Linden-Hubbell Public Schools
Board of Education
Regular Meeting
June 8, 2026**

A Regular Meeting of the Lake Linden-Hubbell Schools Board of Education was held in Room 102 of the High School building on Monday, June 8, 2026. The meeting was called to order by President Patricia Burton at 5:30 p.m.

The meeting opened with the Pledge of Allegiance.
