The Executive Session was deferred to the end of the meeting.

There was one addition to the agenda. Item number 9-A was a motion to accept a letter of resignation from an administrator. There being no other changes to the agenda, a motion was made by Jeff Dennis and supported by Lori Ambuehl to accept the agenda. Roll call vote. Motion unanimously carried.

A motion was made by Lori Ambuehl and supported by Jennifer Beaudette to accept the letter of resignation as presented by Dr. Lisa Perreault Ruhman from her position as Elementary Principal and Middle/High School Assistant Principal. Roll call vote. Motion unanimously carried.

A motion was made by Jeff Dennis and supported by Jennifer Beaudette to move the Board of Education from Open Session of the Special Meeting to a Closed Executive Session for the purpose of discussing collective bargaining under Section 8(c) of the Open Meetings Act at 5:18 p.m. Roll call vote. Motion unanimously carried.
